Law No.143 of the 21st of October 2014

for the amendment of the Government Ordinance No.105/1999 regarding the granting of rights to the persons persecuted by the regimes installed in Romania beginning with the 6th of September 1940 until the 6th of March 1945 on ethnic grounds

ISSUER: THE PARLIAMENT OF ROMANIA

The Parliament of Romania adopts the present law.

ART.1

The Government Ordinance No.105/1999 regarding the granting of rights to the persons persecuted by the regimes installed in Romania beginning with the 6th of September 1940 until the 6th of March 1945 on ethnic grounds, published in the Official Journal of Romania, Part I, No.426 of the 31st of August 1999, approved with amendments and completions by the Law No.189/2000, with the subsequent amendments and completions, is amended as follows:

1. Article 2 will have the following content:

"ART.2

(1) The persons who have been in the situations provided in art.1 paragraph (1) letters a) and b) have the right to a monthly indemnity of 250 lei for each year of deportation or detention.

(2) The persons who have been in the situations provided in art. 1 paragraph (1) letters c), d) and g) have the right to a monthly indemnity of 200 lei for each year of displacement, forced labour or evacuation from their own residence.

(3) The persons who have been in the situations provided in art.1 paragraph (1) letter e) have the right to a monthly indemnity of 200 lei."

2. Article 3 will have the following content:

"ART.3

The surviving spouse of the deceased, from the category of persons provided in article 1 paragraph 1 letters a) - e) and g), as well as the person who has been in the situation provided in article 1 paragraph (1) letter f) benefit beginning with the first day of the month following the month in which the application was submitted,

in the terms of this ordinance, of a monthly indemnity of 150 lei tax free, if latter have not remarried."

ART. II

The rights provided in art.I are granted beginning with the 1st of January 2015.

ART.III

The Government Ordinance No.105/1999 regarding the granting of rights to the persons persecuted by the regimes installed in Romania beginning with the 6th of September 1940 until the 6th of March 1945 on ethnic grounds, published in the Official Journal of Romania, Part I, No.426 of the 31st of August 1999, approved with amendments and completions by the Law No. 189/2000, with the subsequent amendments and completions, as well as with the amendments made by the present law, shall be republished in the Official Journal of Romania, Part I, giving a new numbering to the texts.

This law was adopted by the Parliament of Romania, in accordance with the provisions of art.75 and of art.76 paragraph (2) of the Constitution of Romania, republished.
